Dear Advocates and Clients,

Our Bullfighting Judiciary- Government duo crushing not only the whole nation but your own growth alongwith your clients. Courts are gagged by Tarikh Pe Tarikh scenario.

Our Forum For Fast Justice (Forum) is fighting this deadly virus since last 15 years. Ours is a registered trust and have set up 115 Society For Fast Justice across 23 States of the country and federated them into National Federation of Societies For Fast Justice. We have met who is who in the government, MPs, MLAs, Activists and Commoners. We had our own version of Bharat Jodo, 35 days Nyay Yatra commencing from Delhi's Rajghat on 30eth January to 4th March 2016 covering 180 towns through four mini buses in two groups, travelling across 18000 kms. People enthusiastically welcomed us and joined in processions and meetings. Local media had created great impact on the need of judicial reforms of our judiciary moving at snail speed.

You as advocates working day and night are losing your income and not reaching to final hearing cases. Your poor clients are the most suffering lot.

Three judge bench headed by Justice B.N.Kripal in a judgement between All India Judges Association V/s. Union of India & Ors. [(2002) 4 SCC 247] dated 21st March, 2002, Senior advocate Nariman was made amicus curiae. He referred 85th Report of Parliament's standing Committee headed by Late Pranav Mukherji, submitted in February 2002 suggested to increase judges strength from 10.5 to 50 judges per million population in the country.

Earlier in some of the reports, the Law Commission of India had suggested the same formula of 10.5 to 50 Judges increase per million population.

*S.C. accepted these recommendations and directed Union Government, and all states to implement the order by 2007. **But no action taken by anyone of them.***

Let us all unite and fight against this fatal disease.

We, the Forum trustees, our 115 Societies For Fast Justice and their National Federation, the advocate fraternity and crores of your clients come together in strength unitedly to fight for our right of speedy justice.

We, the Forum trust will embark again on a nationwide awareness campaign to address your bar associations and clients jointly or severally forthwith any time during holidays or on working days during 5 P.M. to 7-30 P.M. You have to arrange a venue like any moderate hall at your cost. We trustees, will come to meet you to interact on this burning issue and stay in hotel if required at our cost.
